It will explore the implementation of a Digital Education Transformation Framework, designed to provide a digital literacy, skills and capability programme across the Saint Francis Hospice workforce, based on an open, inclusive, learner-led environment.</p> <p>In addition to learning from the Demelza children's hospice journey to digital inclusion, this session will focus on driving forward a personalised approach to digital inclusion, reviewing competencies based on individual roles rather than departmental requirements, building confidence, reviewing current skills and available technology through digital transformation, and provisioning of appropriate devices.</p>

	<p>The ways in which Artificial intelligence (AI) is being used and what it might become is capturing the imagination of society, corporations, governments and policy makers alike.</p> <p>In this session, James and Amara will discuss examples of how AI is currently being used by palliative care stakeholders (e.g., patients, hospices and technology providers) to consider its use in clinical practice.</p> <p>James and Amara will discuss AI's potential to improve clinical care in several aspects, for example, to predict illness, support diagnosis, to assist communication and provide treatment recommendations.</p> <p>James and Amara will discuss ethical considerations about the use of the AI in palliative care, which will include discussions about ethical frameworks, governance, bias and trust. The session will conclude by asking how hospices can help in the development, use and evaluation of AI. Specifically, whether hospices should allocate resources to experimenting with AI whilst in its embryonic stage, and how AI can be potentially used in their current tech ecosystems.</p>
